Electric Dept. and Water Supply Dept" and will be received at the office of the undersigned upto 2.00 P.M. the 31st January, 2023 and opening of the Quotation at 2.00 P.M. on the same date.

The Quotation shall be placed in a closed and sealed cover superscribed "Auction for Selling out of Scrap materials" and addressed to the Chairman, Nabadwip Municipality.

-: Rate should be quoted against the following items :-

- 1) Selling out of Scrap materials of Public Health & Convenience Dept. Electric Dept. and Water Supply Dept. as per list are laying at different location of N.M. under physical possession of the Chairman, N.M.
- 2) Sarkari Dak Rs. 40 Lakhs (Forty Lakhs Only).
- 3) The bidder should deposit a sum of Rs. 20,000/- (Twenty thousand only) as Earnest Money Deposit (EMD). The EMD in the form of Demand Draft (DD) in favour of Chairman, Nabadwip Municipality should be kept in an envelope mentioning bidders name and shall be dropped on or before 31/01/2023 at 2.00 PM in the tender box placed at Chairman, Nabadwip Municipality, Chamber. The bids received without EMD will summarily be rejected.
- 4) The EMD of remaining unsuccessful bidders shall be returned to them, without any interest, after finalization of sale/award of work to the successful bidders .
- 5) No items, once deposit from the successful bidders shall be taken back by this office on any condition whatsoever. Any un-cleared or unnoticed materials left over by the purchases within the permises cannot be claimed later.
- 6) The bidders should conduct due diligence on all aspects related to the property to his satisfaction. The bidders shall not be entitled to make any claim against the Authorized officers in this regards at a later date.
- 7) Auction Inviting Authority reserves the right to reject any or all offer/bids for the said auction/sale without assigning any reason thereof.
- 8) The items shall be sold/auctioned to the highest bidders.
- 9) The purchases price shall be quoted in figure and words, in the schedule enclosed and in case of any discrepancy in price quoted in figures and words, the price written in words shall prevail.

- 10) It is responsibility of the bidders to visit the site and to inspect and satisfy themselves about the unserviceable/scrap materials before participating in the bid. The scrap materials for sale can be inspected by interest bidders on all working day during office hours prior or last date of bid submission.
- 11) Conditional tenders will be rejected.
- 12) Acceptance letter to the highest bidders (H-1 bidders) shall be sent through e-mail/ Speed post-Hands delivery.
- 13) The materilas should be cleared away from this office premises within 7 days from the data of issues of bid acceptance letter. There should not be any damage to the properties to this office/ inconvenience in functioning.
- 14) Obtaining allstatutory approvals from the local bodies/Police/Traffic wing required for purchase, Loading/unloading/clearing or transportation of materials is the sole responsibility of the purchaser only.Municipality con not be held responsible for any delayor lapses in this regards.
- 15) The successful bidder are deposit the approved Bidding amount by Cheque & DD on A/C Chairman,.
- 16) Bids should be submitted in a saled envelope superscribing on the top "AUCTION/SALE OF UNSERVICEABALE SCRAP MATERIALS " and dropped in the box kept to the Chairman.
- 17) Bids less than the reserve price fixed by this office shall be rejected after following the due procedure.
- 18) The entireamount paid by the bidders shall be liable for forfeiture without prior notice, if the successful bidder fails to adhere to the terms and conditioned of the Auctioned/ Sale.
